It was a pleasure meeting you Detective Gulka. My Juris Doctorate was conferred at a law school in California, and I graduated in the fall of 2023. I sat for the bar last year and didn't pass by a few points smh. I am preparing to sit for it again. Of course, I have to reiterate that I am not yet licensed, and thus not yet licensed in this state, and thus cannot provide legal representation nor legal advice to the Fraternal Order of Police.

If/when elected, however, I can to liaise with legal acumen as to the city attorney and the police departments and its agents and affiliates to ensure that your employee rights, benefits and legal remedies are being properly regarded as county employees, although still at that time I cannot directly provide legal representation to the Fraternal Order of Police.

As committed, please find additional legal resources regarding negligence claims against the "state" or the city and county, which are of course state agents and thus constitute the "state" for legal purposes.

Under the NC Torts Claims Act, sovereign immunity for the state is statutorily waived. Fraudulent misrepresentation and negligent misrepresentation are torts. Legal malpractice is a tort, as well, in that it is a negligence tort or the tort of negligence.

Find attached some legal resources promulgated by the state of North Carolina, a local law firm and the UNC School of Government, which is an authority on NC law.

Once you've reviewed the legal resources, feel free to ask more specific questions and I'll promptly respond. Understand that if the city attorney has negligently or even fraudulently misrepresented police rights, employee benefits or legal remedies, and if you confront him without first having a solid Notice of Claim, he'll likely obfuscate the validity of your claim(s). He is supposed to represent you, provide you with apt and competent representation and he has a fiduciary duty to do so. Negligent or fraudulent misrepresentation breaches that duty which he inescapably owes you; after all the police do so much for the city ... putting your lives on the line everyday and doing thankless work really.

I am indeed empathetic ... and it is unclear why the city has not "taken better care of you." Like I iterated during my interview, it's like that viral protest sign - "I can't believe [the police] are STILL 'protesting' this."

Media and fellow candidates,

Now, I've seen some odd things along the campaign trail during my 12 year political career. Many have understood the purpose of my trademark, See Tigress run, and my accompanying public statements that I knew there'd be a slow adoption process for a candidate like me, especially that I am completely detached from the status quo, albeit generally or specifically the corrupt status quo, having been primarily self-employed my entire adult life and possessing academia and experience that often makes me the "smartest person in the room."  
And in "political rooms," it makes me the oddball out.

Now admittedly I didn't anticipate the egregious large scale defamation, political bullying and smear campaign tactics, but of course as an intellectual, I "understood" their motive - after all, everything about me represents "draining the swamp" in both mainstream parties and in any and all parties where public corruption persist.

Ultimately, with my son within an earshot, who did resume a defensive stance right beside me in response to Brendan's despicable conduct, Brendan revealed that "Charlotte didn't need any more Blacks in city and county

government" and that "Charlotte didn't need another Black as Mayor" and furthermore since he was "getting all of the endorsements" that it was best for me to drop out of the race, endorse him and then he [do me the favor] of "bringing me into the fold as his expert advisor." Effectually, Brendan propositioned me to be his house slave.

Attached also find my campaign finance account report from June 1, 2025 to today.

Furthermore, in fact, after reviewing my campaign finance account, in that I have only raised \$656 for this campaign, which is well below the \$1,000.00 threshold, there is still yet nothing to report.

Be also that bribery is a crime, and bribery is actionable for both monetary and non-monetary exchanges. Brendan's criminal solicitation and attempt to bribe me, and moreover racially (prejudicially) motivated constitutes an actionable crime. Prosecution for which is RIFE.

I am who I say I am.

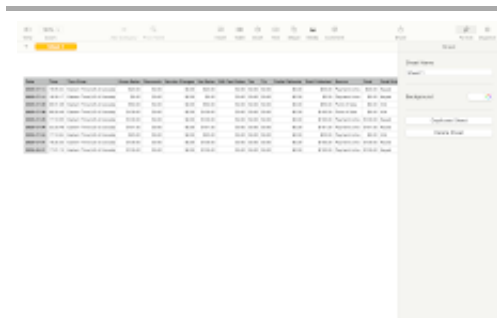

Greetings news outlets, and fellow colleagues, and those members of the Charlotte Fraternal Order of Police I've publicly reported from criminal solicitation, bribery and racism:

When I awoke this morning, I'd received 4 texts and 3 emails forwarding Katowitz' secretly sent email to you all, ironically and self-incriminatingly communicating with you all in a clearly intentionally bifurcated email feed to conceal it from me.

First, I responded to those texts from colleagues thanking them for ensuring that I did see it. They were concerned that the Charlotte FOP, Katowitz, and Brendan would be able to lie their way out of this. I reassured them that they'd already severally demonstrated their guilt, and furthermore, that the secretly delivered responsive email, markedly including Katowitz' surreptitious note, "FYI ...." is the most profoundly doltish, unprofessional, creepy, demonstrably corrupt conduct, especially for someone who holds the title of "Police Chief Emeritus" and executive board member for the Charlotte FOP.

Again, my email was sent publicly, and notably directly and conspicuously included them so as to avoid ex parte communication and give them an opportunity to respond. Actually, as you're all aware - I demanded a response and corrective action from them. There is no way to justify Katowitz, then, secretly sending the Charlotte FOP's response to the addressees I initially included and excluding me from the feed, when their response was PUBLICLY posted on their Meta page. Katowitz' response is proof of what I always say - "Corruption corrupts." It literally corrupts the mind, and Katowitz' judgment is so clouded with corruption that he cannot himself see that each and every responsive act he's taken in this matter is compoundedly incriminating.

Based on Katowitz' conduct, it can be validly inferred that he and certain (unlikely all) members of the Charlotte FOP are co-conspirators with Brendan in his criminal solicitation and attempt to bribe me, motivated with racial prejudice and sexism.

Pay attention to the facts:

1. It can be validly inferred that Katowitz composed and published this post, or at least contributed thereto on behalf of the Charlotte FOP;
2. They failed to even minimally address Brendan's criminal solicitation and attempt to bribe me, motivated by racial prejudice and sexism;
3. All of their statements are obfuscated. All of their references to my statements are wholly false in they clearly wantonly misrepresented the very direct statements I made to confuse the facts and deflect from their liability.
4. They also straightly lied as to seeking my legal advice. Find attached detective Gulka's business card and my email to them as to the legal advice they solicited from me during the interview. If what Katowitz says were true - that they didn't solicit legal advice from me - then my email to them, necessarily random according to Katowitz's lie, answering the questions they asked and reminding them that I was not yet licensed, would be particularly odd and even implausible, especially addressing Detective Gulka who'd I not ever met or had ever received his business card before the interview.

During the endorsement interview, notably the first time we met, he disclosed that he was new here, which is consistent with the fact that I didn't know him. In fact, when the interview began, I led with firmly confronting Katowitz about their suspicious endorsement pattern, questioning their accountability and reminding him that my background was federal, and then asked Gulka for his name because I didn't recognize him, at which time he acknowledged that he was indeed "new here."

Katowitz' conduct and his odd statements about the dispute and settlement during my endorsement interview also demonstrates that Chief Jennings was subjected to not merely "threatening" texts (which of course is sufficient for public censure and other sanctions) but rather also more highly likely racism, public corruption, criminal solicitation by Tariq Bokhari, Katowitz, Gulka, and other CMPD officers and members of the Charlotte FOP, the police whom attempted to play both sides. Because be clear that during my endorsement interview, Katowitz and Gulka severally affirmed that they sided with Tariq Bokhari and vehemently took issue with Chief Jennings because he did NOT support the outer-carrier vests. After all, such a conclusion is also consistent with why the NAACP would intercede on Chief Jennings' behalf in this matter.

It appears that Katowitz, who has severally cited my consistent affirmation to them that "whereas I do NOT seek endorsements at all, I intentionally seek the endorsement of the Charlotte FOP every candidacy to hold them accountable," didn't apprehend what I meant.

I'm a former Federal Ranger with the National Park Service. I admittedly started my green and greys career with scientific research as my primary thrust, but was quickly introduced to law enforcement. I was recruited at a conference at Virginia Tech. The recruiter didn't exactly read "happy scientist" and I'm a military brat and the majority of my immediate and extended family is military so I excitedly accepted the charge. Whereas I did enjoy scientific research at all the parks where I was assigned, the majority of my duties was support of law enforcement, which entailed investigation as well. Some know I've always wanted to be an FBI agent or EPA police, but after having my son and knowing the high safety risks of my career as a ranger, I decided that my "good fight" would be via the courts and public service.

Despite having heard me consistently reiterate my stance, Katowitz clearly didn't realize that I have always been investigating them. Always. I had absolutely no expectation that they'd endorse me, because everything about me represents their take-down. In fact, one of the member officers, notably a fellow Black person - male - also approached me after last Tuesday's meeting asking why they'd still not endorsed me. And I told him just that. He looked me directly in my eyes, shook my hand firmly and nodded in agreement and left.

Foremost, I'm impressed by the masses who are starting to realize that too many of our agencies are compromised and starting to directly question corrupt institutions. I like to take credit for that enlightenment, at least partly because I've remained pragmatic in bringing the public's attention to this phenomenon.

I not ever expected the Charlotte FOP to endorse me, a staunch anti-corruption politician, because all of the evidence pointed toward the greater likelihood that they were corrupt.

I don't hem and haw. I've been consistent in my statements hereupon. Most recently, I made consistent declarative statements during my public conversation with Dedrick Russell.

Unlike the cowardly Katowitz, Gulka and Brendan, I've once again conspicuously included them in this email chain. Vi should've publicly censured and reprimanded Tariq. Vi should've publicly censured and reprimanded Katowitz and whomever other CMPD officer was involved. I've publicly rebuked and reprimanded them without the authority of mayor, and instead as a fellow Charlottean with whom Katowitz, *in the capacity of an affiliate agency to city and county government, because be clear he possesses no other authority*, and his counterparts are enjoined by the North Carolina criminal code to conduct themselves lawfully.

I am planning a press conference on this matter.

To the news outlets, I'm available tomorrow morning or afternoon - are you? Or Monday at 1p.

Charlotte wants and DESERVES to eradicate corruption in our city and county government and agencies. Cover this matter. I challenge you as I have before. With me in office, Charlotte can realize the reform its been demanding for decades.

Also, when opening Adobe to redact the email forward I received as to Katowitz unintelligent and doltish attempt to secretly and creepily deliver his email to y'all, I received an email from the Democratic Men, notably a brand new PAC, with absolutely no dog in this fight, sent me an email effectually disinviting me to their endorsement based candidates' meeting tonight. Their "decision" is a show of condonement of the Charlotte FOP's and Brendan's sexism, racism, and criminally actionable public corruption. I take it as a compliment to be disinvited, and this is further reason why the news outlets need to cover this matter.

We all witnessed that sexism and racism, and its intersectionality as to candidates' who oppose the corrupt status quo, unlike Vi who is in bed with it, was the primary reason Kamala Harris was not elected.

Whatever Katowitz, Brendan and the men they've clearly enlisted to persist upon deflecting from accountability and corrective action think they're doing more likely will have the opposite effect. Since sitting down to compose this email, I've received countless dm's and messages from women, Black women particularly, expressing their solidarity and even sharing their experiences with some of the members of the Charlotte FOP and CMPD, particularly the Caucasian males, having been subjected to racism, sexism and public corruption.

I'll look out for the response from the news outlets regarding scheduling my press conference.  
Let's take out the trash together!

- ✗ We have never sought legal advice from Dr. McDaniels, nor would we.

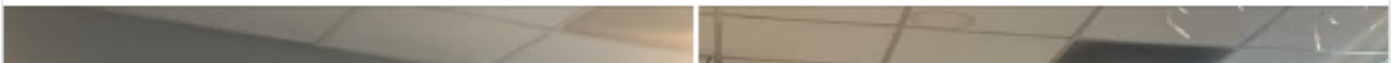
Her email was received—and its tone matched the tenor of her video.
