NOW COMES Defendant Tigress Sydney Acute McDaniel, *Juris Doctor* (hereinafter "McDaniel"), having further discovered, through a pleading filed by Defendant's counsel in a pending complaint that McDaniel initiated, that Emily Jeffords Meister (hereinafter "Meister"), Keith T. Black (hereinafter "Black"), Jennifer L. Reutter (hereinafter "Reutter"), and, by and through Rossabi Black Slaughter PA have perpetrated registration of the November 25, 2014 Gatekeeper Order entered by Judge Carl Fox (hereinafter "Fox"), filed on December 8, 2014 against McDaniel, in AT LEAST 72 counties in the state of North Carolina, upon information and belief derived from subject Defendants' attorneys in Mecklenburg and Wake complaints for which McDaniel is notably Plaintiff regurgitating Richard Long Huffman's (hereinafter "Huffman") perjurious 2016 affidavit of materiality in fraudulently representing that,

"Furthermore, due to her repeated filings, which exhibit abuse of the legal system and a tendency of harassing behavior, Gatekeepers order have, upon information and belief, been entered against McDaniel in the following 24 counties: Ashe, Chatham, Cumberland, Davidson, Duplin, Edgecombe, Franklin, Gaston, Granville, Halifax, Hertford, Martin, Mecklenburg, McDowell, Mitchell, North Hampton, Perquimans, Randolph, Richmond, Rowan, Sampson. Stanly, Swain, Vance, Wilson, Union"

and otherwise, at least, the following counties, in gross violation of Judge Patricia Hinnant's (hereinafter "Hinnant") May 27, 2014 Amended Gatekeeper Order and the Superior Court Judge's Bench Book for North Carolina,

and additionally Fox has perpetrated registration of his gatekeeper order above cited against McDaniel in the following counties in the state of North Carolina:

and furthermore, said Leisa Ann Meister (hereinafter “Leisa”) has perpetrated registration of a gatekeeper order against McDaniel in Buncombe county,

and having reviewed Huffman’s original perjurious affidavit from which these knowing lie that “McDaniel initiated approximately 164 in 72 counties of NC” and “24 counties of NC have entered a gatekeeper order against McDaniel” stems, and confirmed with these 24 counties that Huffman’s perjurious affidavit does, in fact, constitute perjury in that none of the 24 counties discussed supra, notably which Huffman cited and to which he attested, have a gatekeeper order entered in its county against McDaniel NOR are there any cases records at all for which McDaniel is a party (records attached and incorporated herewith),

and even moreover that Plaintiff and her co-conspirator counsel of record, Black

to hereby move this court to immediately vacate the gatekeeper order and strike unlawfully perpetrated registration of Judge Carl Fox’s December 4, 2014 gatekeeper order from ALL COUNTIES DISCUSSED SUPRA AND OTHERWISE ALL 100 COUNTIES OF THE STATE OF NORTH CAROLINA and so says in support thereof:

1. McDaniel’s factual litigative history began in 2005, and in such actions she prevailed in the majority of her complaints, albeit as Plaintiff or Defendant, which were markedly exclusive to her places of residence or the place material to the wrongful conviction she suffered and the principal office location for Michelle Feimster Bailey and Infinity Bail Bonds, LLC (hereinafter collectively “Bailey”) , her bail bondsman against whom she was awarded a money judgment in 2006 for relief and remedy from destruction of her

vehicle that had been used to secure bail: Guilford, Forsyth, Rowan and Cabarrus counties.

2. McDaniel had not ever been subject to any sanctions nor a gatekeeper order PRIOR TO THIS ACTION, 13CVS8774, initiated by Emily Jeffords Meister in 2013 as the case number denotes.
3. McDaniel has NOT even visited nor initiated or otherwise been party to any actions in any of the counties discussed supra except Cabarrus, Guilford, Forsyth, Rowan and Mecklenburg where most notably the gatekeeper order is under appellate review, and McDaniel has already brought to this court's attention, showing that McDaniel has litigative history in only 5% of the 100 counties in the state of North Carolina, and exclusively so;
4. The 24 counties where Huffman perjurally attested had entered gatekeeper orders against McDaniel have confirmed that (1) **there is no gatekeeper order entered against McDaniel in its county, which is accurate**, because (a) the registration of a gatekeeper order in another county DOES NOT constitute an enforceable gatekeeper order in that county AND (b) gatekeeper laws prohibit a gatekeeper order from being entered and enforced in a county other than the county at issue, which in this case, albeit effectuated by fraud and thus constituting a void ab initio order and furthermore constituting nullity and unenforceability, is limited to Guilford County, AND (2) moreover none of these 24 counties show any cases at all for which McDaniel is a party, which is also accurate demonstrating that McDaniel's averment in her preceding pleadings is demonstrably factual as averred, and even more so, (3) **no county except** *for Guilford, Forsyth and Mecklenburg, where she has factually resided, and secondarily Cabarrus and Rowan,*

exclusive to the wrongful conviction she suffered in 2006 and her money judgment against Bailey related thereto, and otherwise only recently in Wake County in 2023 as to McDaniel's escalated relief and remedy against the state of North Carolina and its agents and co-conspirators and Does due to bad faith corrupt enforcement of the knowingly fraudulent gatekeeper order in Guilford, Forsyth, Cabarrus, and Mecklenburg, totaling 6 counties out of the 100 counties in this state, shows any cases at all for which McDaniel is a party, which is accurate;

5. Prior to 2023, McDaniel has repeatedly and wholly shown the court that the gatekeeper order history is specifically, and most markedly, limited to only THREE COUNTIES: Guilford, Rowan and Mecklenburg. **Furthermore, all such gatekeepers orders were entered ex parte, based upon wholly falsified information initially certified by Richard Huffman, counsel for Michelle Feimster Bailey, falsely swearing to a completely fraudulent fabrication that "McDaniel has initiated 162 actions in 72 counties [of NC],"** (attached herewith) **and motivated by unlawful retaliation to evade liability for Plaintiff's merited complaints regarding (1) Michelle Feimster Bailey, against whom she had a 2006 money judgment for which she sought renewal in 2016 and had notably obtained Default Judgment in Rowan county, (2) racial discrimination at Ham's Restaurant in Greensboro, NC for whom Emily Meister appeared as counsel and attempted to intimidate both Plaintiff and her friend who accompanied her during the incident at Ham's Restaurant, and otherwise improperly adjudicated by judges who were subject to recusal in Guilford county (3) the repeated violations of Plaintiff's minor child's 504 plan by Charlotte Mecklenburg Schools, markedly admitted by the teacher at issue, this violative**

incident which resulted in minor child allergic reaction, hospitalization and surgery in Mecklenburg county.

6. **McDaniel has demonstrated that there has not ever been a gatekeeper order entered against her for just cause, nor one entered with lawful regard to her hearing rights, nor one entered in any other counties than Guilford, Rowan, and Mecklenburg, showing that the only gatekeepers orders that exists, notably unlawfully, are limited to 3% of the 100 counties in the state of North Carolina.**
7. McDaniel has also shown that these gatekeeper orders have been justly subject to review and modified or vacated altogether in McDaniel's favor; then, in the case of Mecklenburg county, just recently reinstated on May 21, 2021 sua sponte by Judge George Bell, without just cause, who had only one month prior vacated the gatekeeper order finding that the gatekeeper order violated Plaintiff's constitutional rights and further that 100% of McDaniel's pleadings had been approved for filing under the gatekeeper order demonstrating that she was not an abusive filer as previously alleged (attached herewith). The despicably corrupt improper use of the gatekeeper order to "win" cases against McDaniel that are substantiated by prima facie evidence, and thus indefensible, demonstrates the gross misconduct of the attorneys and judges who have played a role in effectuating the ill-gotten and fraudulent gatekeeper order.
8. In fact, in 2023, Debra Sasser, who has was notably forcibly retired subsequent to the copycat fraudulent gatekeeper order entered in Wake County, due to her history of racial prejudice against African Americans like McDaniel, was motivated by the same constructive fraud that Fox, Lindsay Davis (hereinafter "Davis"), Meister, and Black in Guilford County, Anna Mills Wagoner (hereinafter "Wagoner"), Huffman, and Bailer in

Rowan County, and Lisa Bell (hereinafter “Lisa”) and George Bell (hereinafter “George”) in Mecklenburg County engaged;

9. ALL of the gatekeeper orders directly violate NC Superior Court Judges’ Bench Book (attached herewith) in that the gatekeeper is NOT narrowly tailored, and grossly so.
10. Judge Patricia Hinnant’s (hereinafter “Hinnant”) May 27, 2014 order (attached herewith), which is notably the beginning of the gatekeeper order history AMENDED in McDaniel’s favor, due to its gross unconstitutionality, directed Emily Meister against using the gatekeeper order to “penalize ... retaliate against [McDaniel] by Meister OR ANY PARTY IN ANY OTHER MATTER PENDING WHICH INVOLVES HER BY THE FILING OF THIS ORDER INCLUDING DELAY IN FILING RESPONSIVE PLEADINGS.”
11. Moreover, Hinnants’ May 27, 2014 also stipulated that “The Preliminary Gatekeeper Order shall be vacated as to all matters not related to Meister.”
12. Where opposing counsel will likely argue that Fox’s subsequent gatekeeper order effectually reinstates the gatekeeper “as to any and all matters related to or unrelated to Meister,” Fox’s order directly violates the Superior Court Judges’ Bench Book and all binding legal authority for gatekeeper because his order was predicated and effectuated upon constructive fraud in that the facts hadn’t changed as to Hinnant’s preceding finding that Meister failed to show any conduct by McDaniel that rose to the level of an actionable gatekeeper order, AND in that it is whereas the gatekeeper order itself is narrowly tailored to Guilford County, the fraudulent and constitutionally violative registration of that gatekeeper order in “100 counties of North Carolina” grossly violates McDaniel constitutional protections and grossly, directly violates gatekeeper laws which

requires that a gatekeeper order is narrowly tailored to the county for the purported circumstances showing abuse or narrowly tailored to the related party(ies) for the purported circumstances showing abuse.

13. In fact, Judge Carl Fox's statements in purporting to specify the history that led to the entry of his December 4, 2018 gatekeeper order is wholly fraudulently misrepresented to give the appearance of McDaniel engaging abusive litigation, when in reality, the cases that he cites as a demonstration of abusive litigation are, instead, mechanic man's liens on a commercial property formerly leased by McDaniel from which she was constructively evicted due to city condemnation, and thus entitled to such lien and remedy for the same, and otherwise, merited complaints that were unjustly disposed while McDaniel was awaiting hearing on her relief motions against the Preliminary Gatekeeper entered by Judge James Webb (hereinafter "Webb") in 2013 which was most markedly AMENDED in McDaniel's favor in 2014 by Hinnant due to its gross unconstitutionality for reasons including but not limited to "delay in review and filing of her responsive pleadings."
14. Even more so, as to Webb's preliminary gatekeeper order, discussed supra, Meister's and her co-conspirators' registration of THAT preliminary gatekeeper order still yet appears on record in all of the counties that they criminally and alternatively negligently perpetrating the registration thereof in addition to Fox's subsequent void ab initio gatekeeper order, which preliminary gatekeeper order is defunct in that it was replaced by Fox's order; and in that Webb's preliminary gatekeeper order was even more so unlawfully restricting, such continued registration directly violates gatekeeper laws and McDaniel constitutionally inviolate due process rights.

15. The gatekeeper order has been used by subject attorneys and judges to wholly bar McDaniel's litigation in a conspired act to subserve unmerited disposition and evade liability for her properly pleaded complaints, consistently asserted upon prima facie evidence.
16. Fox's December 4, 2018 order identifies McDaniel as "Tigress Sydney Acute McDaniel f/k/a Tosha Renae McDougal" without just cause, seeking to evoke the disdain of the entire state of North Carolina court system against her and deceitfully attributing criminal inferences to her legal name change, which is wholly falsified, baseless and absurd.
17. Fox's December 4, 2018 order directly violates the Superior Court Judges' Bench Book in that it fails to include opportunity for modification.
18. In his December 4, 2018 order, Fox also trivializes and fraudulently misrepresents the specific stipulations entered by Hinnant in her May 27, 2018 order drastically MODIFYING Webb's October 8, 2013 Preliminary Gatekeeper Order, and instead emphasizes only the components of the gatekeeper orders that further perpetrate McDaniel as a purportedly abusive filer.
19. In his December 4, 2018 order, Fox fraudulently misrepresents the dispositions of McDaniel's litigative history in Guilford county, in so much as also inadvertently admitting that yet another gatekeeper order was entered her in 13CVM8795 and 13CVM8714 WITHOUT REGARD TO PROPER NOTICE to McDaniel NOR ANY REGARD TO HER HEARING RIGHTS.
20. The subject judges and attorneys have fraudulently misrepresented the gatekeeper order exaggerating the circumstances purportedly showing abuse, when in reality, a closer look shows that McDaniel's claims in relief are demonstrably factually as alleged in that,

- a. McDaniel has NOT ever filed a frivolous complaint, and instead, any complaint that has led to a gatekeeper order named a party, for whom its counsel was willing to corrupt their oath of license and engage litigative fraud to effectuate an ill-gotten “win” against her, so as to not been seen as inferior to a pro se litigant;
- b. McDaniel has prevailed in the vast majority of her complaints, and actions for which she was Defendant;
- c. The gatekeeper order has been perpetrated in a knowingly malicious and corrupt copycat manner to effectuate ill-gotten “wins” against her in Rowan and Mecklenburg County, where she had absolutely no history of abusive litigation. After all, in Rowan county, McDaniel suffered from the attorney and judicial fraud conspired by Anna Mills Wagoner and Richard Huffman, after renewing a 2006 money judgment against Michelle Feimster Bailey in 2016, and had notably obtained Default Judgment, and meritedly so, and in Mecklenburg county, McDaniel became subject to a gatekeeper order only after suing Charlotte Mecklenburg Schools for repeated gross violations of her minor child’s 504 plan which resulted in his physical injury, hospitalization and surgery.

- 21. The gatekeeper orders altogether violate McDaniel’s constitutionally inviolate right to due process, to which a fair trial and hearing rights are indefensibly inherent.
- 22. The gatekeeper order altogether violates McDaniel’s constitutionally inviolate right to access to the courts.

23. The fraudulently copycat gatekeeper orders have been maliciously perpetrated in Mecklenburg and Rowan counties to wholly bar Plaintiff from proceeding upon even indefensibly merited complaints, notably supported by prima facie evidence.
24. Both Mecklenburg and Rowan counties have grossly delayed review of McDaniel's pleadings submitted in accordance with the gatekeeper order, and more often completely ignored McDaniel's pleadings, employing the gatekeeper order as a weapon of retaliation to intimidate her from litigating markedly valid complaints, or simply defending against wrongful summary ejectment actions for which fit premises or landlord's breach of mutuality of obligations was shown.
25. In fact, the gatekeeper order(s) have been so grossly, fraudulently misrepresented that McDaniel cannot enjoy a fair trial in Rowan, Mecklenburg, Guilford or Cabarrus counties.
26. Even moreover, the gatekeeper order(s) have been so grossly, fraudulently misrepresented that McDaniel, *when it was reasonable to afford prior to the libelous articles published in The Charlotte Observer with the clear specific intent to inflict the specific harm of discreditation, villification and economic hardship*, cannot employ legal counsel in Rowan, Mecklenburg, Guilford or Cabarrus counties or any other county in North Carolina.
27. Whereas McDaniel is perfectly apt to litigate on her own behalf, and even more so McDaniel possesses notable litigative acumen, which is the reason for Meister's retaliatory fraudulent gatekeeper motion in striking a fatal blow to McDaniel's defensive litigation, the bad faith corrupt enforcement of the gatekeeper order thwarts her natural justice.

28. The gatekeeper order(s) have been maliciously conspired and perpetrated to subject McDaniel to public disdain, discreditation, victimization, vilification, ostracization, and harassment.
29. The gatekeeper order(s) have been maliciously conspired and perpetrated to deny McDaniel's natural justice in prima facie complaints.
30. McDaniel obtained her Juris Doctorate in 2022, and thus is NOT a layperson.
31. Even laypersons are NOT subject to a gatekeeper order in the manner and with the criminal mens rea and actus reus as McDaniel has been.
32. To date, Meister and Black have failed to show any conduct by McDaniel which validly exposes her to the gatekeeper order.
33. McDaniel has NOT initiated ANY actions in Guilford county since 2014.
34. McDaniel has NOT initiated ANY actions against Meister, Black, Reutter, nor Rossabi Black Slaughter PA since 2014 except her valid complaint against the state, its actors and co-conspirators for (1) constructive fraud, (2) bad faith corrupt enforcement of the fraudulent gatekeeper order and (3) injunction, which is, in fact, a claim for which relief can be granted under North Carolina AND there exists ultima facie justification for such complaint entitling her to summary judgment and preliminary and permanent injunction against the state, its actors and co-conspirators, namely including Meister and Black, Jamies Melissa Woods (hereinafter "Woods"), F. Lane Williamson (hereinafter "Williamson") and subject judges Wood, McGee, Sasser, Wagoner, Fox's estate, Davis, Webb, George, Lisa, and all other named Defendants in both their individual capacity as to criminal liability as to their criminally motivated constructive fraud and official

capacity as to their civilly actionable negligence, and delineated liability as to variations permitted by law.

35. MCDANIEL HAS ABSOLUTELY NO CONNECTION WITH ANY OF THE COUNTIES WHERE SUBJECT ATTORNEYS AND JUDGES HAVE PERPETRATED REGISTRATION OF THE GATEKEEPER ORDER EXCEPT GUILFORD, ROWAN, MECKLENBURG, FORSYTH AND CABARRUS, WHICH NULLIFIES FOX'S ORDER DIRECTING THE REGISTRATION OF SUCH GATEKEEPER ORDER IN COUNTIES OF NO RELEVANCE.
36. On September 19, 2023, McDaniel visited the Guilford County Clerk's Office and did obtain a comprehensive record of all actions for which she is party (attached herewith), which most disturbingly shown the registration of the gatekeeper order effectually duplicated in counties throughout North Carolina without regard to due process and laws governing gatekeeper orders.
37. In reviewing such record, McDaniel has prevailed in over 59 complaints that she has initiated since 2006.
38. The vast majority of the remaining records are exclusive to the corruptly perpetrated registration of the gatekeeper order in counties throughout North Carolina, leaving ONLY 23 ACTIONS WHICH WERE EITHER UNJUSTLY DISPOSED WHILE MCDANIEL AWAITED RELIEF FROM THE 2013 GATEKEEPER ORDER UNDER THE GUISE OF ADJUDICATION ON THE MERITS OR PREJUDICIALLY DISPOSED IN MECKLENBURG COUNTY UNDER A PURPORTING THAT THE GATEKEEPER ORDER HAD THE LEGAL EFFECT OF WHOLLY BARRING ANY OF HER COMPLAINTS, THUS DENYING HER RIGHT TO DUE PROCESS.

39. These remaining 23 actions that were disposed in an opposing party's favor were effectuated by unlawful prejudice motivated by evoking the disdain of the courts regarding this action falsely pleaded by Emily Jeffords Meister purporting to indefensibly assign liability to McDaniel for defamation per se stemming from McDaniel's 2013 TRO complaint against Meister for her harassingly intimidating assault upon McDaniel and her friend, Alexandria, who accompanied her at Ham's Restaurant, the incident material to the preceding civil complaint for racial discrimination, after leaving a preliminary hearing in that case, which markedly Detective Steve Flowers responded at the intercessory plea by McDaniel and Alexandria, who testified in these matters (subpoena records attached herewith; Judge Susan Burch did not allow Detective Steve Flowers testimony nor the audio/video surveillance footage at the courthouse). Through these prejudicial disposals, the presiding judges deemed otherwise curable litigative defects like service issues as sufficient to wholly dispose of McDaniel's cases:

- a. 13CVD8328 was disposed by Judge Susan Burch on the sole finding that there had only been ONE actionable incident of stalking committed by Meister, and thus insufficient to warrant a TRO, as opposed to ONE actionable incident of assault which would indeed warrant a TRO; so, the case was not decided in Meister's due to innocence;
- b. Similarly, the cases as to Charles Miller were disposed due to Miller engaging a malicious pattern and practice of evading service, even to the extent of evading the service by the Greensboro City Code Enforcement, which is well documented on city record; so, the cases against him were not decided in Miller's favor to absolution;

- c. Similarly, the case as to Dr. Vincent Paul was dismissed because McDaniel's medical doctor witness who had agreed to testify to show that Dr. Paul had, in fact, committed malpractice which directly resulted in McDaniel's nerve injury and suffering Complex Regional Pain Syndrome since the unauthorized and improper administration of cortisone, reneged, and thus McDaniel's complaint lacked the statutory requirement for a witness of the competent expertise to show malpractice, but the case was NOT dismissed due to frivolity on McDaniel's part.
- d. So, when properly reviewing McDaniel's case without objective scrutiny, it is demonstrably factual that Plaintiff has NOT EVER ENGAGED ABUSIVE LITIGATION, THUS DEMONSTRATING THAT ALL OF HER ACTIONS WERE HIGHLY LIKELY DEMONSTRABLY FACTUAL AS ALLEGED AS OPPOSED TO THE OPPOSITE PREJUDICIAL THEORIES CONSPIRED BY THE SUBJECT JUDGES AND ATTORNEYS;
- e. Particularly considering Meister's unlawful and maliciously duplicative registration of the Guilford County gatekeeper order perpetrated in counties throughout North Carolina, it FURTHER DEMONSTRATES THAT MCDANIEL'S CLAIMS FOR ASSAULT AGAINST MEISTER WHICH WAS WITNESSED BY ALEXANDRIA AND DETECTIVE STEVE FLOWERS ARE MORE LIKELY FACTUAL AS ALLEGED AS OPPOSED TO THE OPPOSITE PREJUDICIAL THEORIES CONSPIRED BY THE SUBJECT JUDGES AND ATTORNEYS;

40. Contrary to the corrupt portrayal of McDaniel's litigative history, the record distinctly shows that she does NOT have an abusive litigative history, FOR WHICH HINNANT TOOK JUDICIAL NOTICE IN HER PRECEDING ORDER.

Regarding McDaniel's notably defunct birth name, verifiably so since 2004, McDaniel moves this court to strike all reference to her birth name in this case for the following legal reasons:

41. Referring to or otherwise identifying McDaniel by her defunct birth name serves no legitimate purpose except to harass and baselessly subject her to criminalization under the wholly unproven frivolous, and more directly, malicious allegations and innuendos by subject corrupt attorneys and judges that McDaniel "may have changed her name to evade criminal charges;"
42. TWENTY YEARS have elapsed since McDaniel changed her name, and markedly lawfully so, and she has NOT used her defunct birth name since that time; in fact, McDaniel has been known as "Tigress" since, at least, 1994, in that, as popularity and recognition grew for her nickname given by her father, the name "stuck" and McDaniel has even been regularly featured in news articles and other publications as "Tosha 'Tigress' McDougal" well before legally changing her name in 2004;
43. In fact, if the criminally minded subject attorneys and judges are seeking to ensure that McDaniel cannot somehow "remain on the lam" evading the criminal charges spawn from their psychotic, doltish, and even imbecilic lies defaming her considerably unrivaled ethical and lawful rigor under the circumstances by which she has been relentlessly victimized, then identifying McDaniel by her proper legal name and completely so, "Tigress Sydney Acute McDaniel," is the most apt method to locate and patrol her, in

that there is absolutely no use of “Tosha Renae McDougal” since 2004 except ironically by Meister and her co-conspirators and moreover McDaniel is a politician and public figure with significant name recognition as “Tigress;”

44. Furthermore, the legal effect of changing one’s name is to abandon the prior name, and therefore, there exists no one named “Tosha Renae McDougal,” especially as it relates to McDaniel;


McDaniel reserves the right to present additional evidence upon further discovery of the misconduct of subject judges and attorneys.

North Carolina prohibits permanent gatekeeper orders, and mandates that a gatekeeper order must include an “opportunity for modification.” Accordingly, Wood nor any judge has the authority to dismiss *with prejudice* McDaniel’s Motion to Vacate the Fraudulent Gatekeeper Order, and thus McDaniel proceeds upon this impending renewed motion to vindicate the United States Constitution with which the state of North Carolina and its agents are inescapably enjoined to wholly comply.

WHEREFORE, McDaniel has proven prima facie violations of all governing law for gatekeeper orders, and demonstrated that Plaintiff and her co-counsel colleagues, and other subject attorneys and judges have engaged pattern corruption of their oath of license and office to subject McDaniel to the specific harms detailed herein, and that the gatekeeper order was fraudulently effectuated and duplicatively registered in, at least 72 counties in North Carolina, and used in a manner prohibited by North Carolina and federal law,

1. the gatekeeper order against McDaniel in Guilford County MUST BE VACATED IN TOTO AS A MATTER OF LAW AND FURTHERMORE, IN FACT, IN THAT THE GATEKEEPER ORDER WAS PREDICATED AND EFFECTUATED BY FRAUD, SUCH ORDER CONSTITUTES A VOID AB INITIO ORDER, AND THUS CONSTITUTES NULLITY, AND THEREFORE IS VOID AND UNENFORCEABLE;
2. the registration of the gatekeeper order against McDaniel perpetrated by Judge Carl Fox, Emily Jeffords Meister, Keith T. Black, and Jennifer L. Reutter in ALL COUNTIES OF NORTH CAROLINA MUST BE STRICKEN FROM THE RECORD(S) IN TOTO;
3. the registration of the gatekeeper order against McDaniel perpetrated in Buncombe county by said Leisa Ann Meister MUST BE STRICKEN FROM THE RECORD(S) IN TOTO;
4. Regarding full accounting, McDaniel also hereby requests that a comprehensive tally of the actions in which she prevailed be stipulated in the order on her relief;
5. All scandalously defamatory and harassing statements about McDaniel, like referring to her as a “notorious litigant,” and/or “McDaniel has initiated 162 cases in 72 counties [of NC],” and any similar violations of Rule 11 as to McDaniel MUST BE STRICKEN FROM THE RECORD(S) IN TOTO;
6. All references identifying or otherwise naming McDaniel as “Tosha Renae McDougal” MUST BE STRICKEN FROM THE RECORD(S) IN TOTO;

WHEREFORE, Plaintiff requests to be heard on these matters at the earliest session of Superior Court in full observance of her inviolate constitutional rights to due process, albeit procedural or substantive.

Richard L. Huffman, being first duly sworn, deposes and says:


1. I am an attorney licensed to practice law in the State of North Carolina and have been since 1981. All matters set forth herein are based on my personal knowledge.
2. I have practiced law in Rowan County since 1994.
3. I represent the Defendant in this matter, as well as Michelle Bailey, former owner of the defunct Infinity Bail Bonds, LLC. Michelle Bailey, in her individual capacity, has also been named in numerous complaints filed by the Plaintiff but is not a Defendant listed on the Complaint in the case at hand.



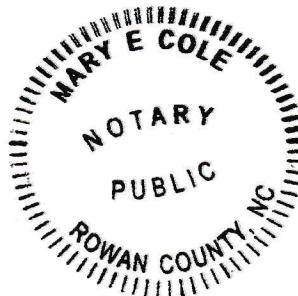



MOTION FOR GATEKEEPER
ORDER

NOW COMES the Defendant and hereby moves for sanctions against the Plaintiff pursuant to Rule 11 of the North Carolina Rules of Civil Procedure. The Complaint, filed pro se, is not well grounded in fact, is not warranted under existing law or good faith argument for the extension modification or reversal of existing law.

1. The Plaintiff's Complaint contains claims that are completely meritless. The Plaintiff has already had seven cases filed in Rowan County against Infinity Bail Bonds, LLC and/or Michelle Bailey all involving the same matter of a bail provided to the Plaintiff by the Defendant in 2006.
2. Attached hereto as Exhibit A is a printout from the Clerk of Courts office listing all cases involving Tigress McDaniel in North Carolina. According to my count, the printout shows 162 different listings in 72 different counties. Guilford County has suffered from the most filings of the Plaintiff with 58 matters listed in the printout. Rowan County has the second largest number of cases listed with a total of 10, 8 of which are filed against Infinity Bail Bonds, LLC and/or Michelle Bailey. The 8 Rowan cases all involve the same bond the Defendant provided to the Plaintiff when she was incarcerated for identity theft and fraud.
3. In the most current filings, Plaintiff filed a case against this Defendant captioned as 13-CVD-2744. That Complaint contained substantially the same allegations as set forth in the current complaint. The Plaintiff subsequently filed another case against the Defendant captioned as 16-CVD-500. It also contained substantially the same allegations as set forth in the current complaint. 16-CVD-500 was dismissed by the Honorable James Randolph on November 30, 2016. The Plaintiff thereafter filed a Notice of Appeal of that order but has failed to perfect that appeal. The current case


also contains substantially the same allegations as set forth in the prior two complaints.

4. Plaintiff's repeated filings has placed an undue burden on the judicial system causing the expense time by Judges, employees of the Clerk of Superior Court, the Trial Court Administrator, Judicial Assistance and Court Reporters. The repeated abuse by the Plaintiff of the legal process requires special limitation be placed upon the Plaintiff's access to the courts of Rowan County.
5. Many of the civil matter initiated by McDaniel involved claims against the same parties, or some of them, which claims arose from the same or almost the same underlying events. Additionally, several of the actions were re-filed despite previous dismissals with prejudice and/or while other actions filed by McDaniel against the same defendant(s) were still ongoing.
6. Many of the claims filed or initiated by McDaniel have been dismissed at various stages due to the failure of McDaniel to appear and prosecute her claims or for failure to present a valid claim.
7. The actions of McDaniel as described above have shown that she has filed baseless claims and motions for the improper purpose of harassing adverse parties, costing them unnecessary time and expense in responding to her filings.
8. The history of McDaniel, who has acted *in forma pauperis* and *pro se* in the matters involving Bailey and the cases judicially noticed by this Court, demonstrates that she is either unable or unwilling to follow the requirements of North Carolina law, including the North Carolina Rules of Civil Procedure.
9. The repeated abuse of legal process by McDaniel requires that special limitations be placed upon her access to the courts. This Court has the inherent power to impose such special limitations as are reasonably necessary for the proper administration of justice and to provide solutions which enable the process of litigation to proceed smoothly. Aspects of that power included the authority to regulate and discipline those persons who appear before the Court to prevent impropriety and to fashion a remedy to meet the circumstances of each case.
10. The nature of McDaniel's conduct and the extraordinary circumstances of this matter, and other cases litigated by McDaniel *pro se*, require that the Court enter a Gatekeeping Order placing special limitations on McDaniel's access to the courts.
11. Gatekeeper Orders have been entered against McDaniel in the following 24 counties: Ashe, Chatham, Cumberland, Davidson, Duplin, Edgecombe, Franklin, Gaston, Granville, Halifax, Hertford, Martin, McDowell, Mitchell, North Hampton, Perquimans, Randolph, Richmond, Sampson, Stanly, Swain, Vance, Wilson, Union.

The Defendant moves the court for a Gatekeeping Order regarding the Plaintiff requiring that any further complaint, motion, pleading or other documents may be filed only with a certification by an attorney licensed under the law of the State of North Carolina to practice in North Carolina. That, in the opinion of the attorney, the document complies with Rule 11 of the Rules of Civil Procedure and that the filing is first allowed by the Chief District Court Judge or Superior Court Judge as the case may be.

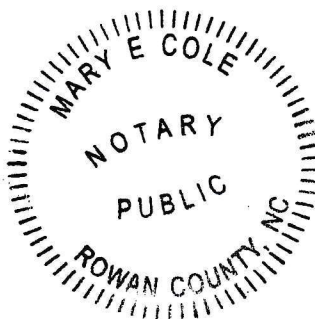

On October, 8, 2013, the Honorable James M. Webb entered the enclosed Gatekeeper Order against Tigress Sydney Acute McDaniel f/k/a Tosha Renae McDougal ("Ms. McDaniel"). The Gatekeeper Order, which directed the Guilford County Clerk of Court (with our firm's assistance) to serve a copy upon all Clerks of Court, Chief Magistrates, Chief District Court Judges and Senior Resident Superior Court Judges within the Fifth and Sixth Superior Court Judicial Divisions, prohibits Ms. McDaniel from:

- (1) Initiating, filing or submitting in the Small Claims Division of the District Court of any county located within the Fifth and Sixth Superior Court Judicial Divisions any further complaint, motion, pleading or other document, unless such filing or document(s):
 - (a) contains a certification by an attorney licensed under the laws of the State of North Carolina to practice law in North Carolina that, in the opinion of that attorney, the document complies with Rule 11 of the Rules of Civil Procedure; and
 - (b) is first allowed by the Chief Magistrate Judge of the county in which such Small Claims Division is located and in which McDaniel seeks to file the document or initiate a proceeding.
- (2) Initiating, filing or submitting in the District Court of any county located within the Fifth and Sixth Superior Court Judicial Divisions any further complaint, motion, pleading or other document, unless such filing or document(s):



Moreover, pursuant to the Gatekeeper Order, these restrictions apply to all filings in the Fifth and Sixth Superior Court Judicial Divisions, not just initial filings.

Your attention to this Order and assistance in carrying out its terms is greatly appreciated.

PRELIMINARY GATEKEEPER ORDER

THIS MATTER coming on to be heard and being heard before the undersigned Superior Court Judge at the regularly scheduled October 7, 2013 session of Civil Superior Court, Guilford County, North Carolina, on Plaintiff Emily Jeffords Meister ("Meister")'s request for a preliminary pre-filing injunction or gatekeeper order, pursuant to Rule 11 of the North Carolina Rules of Civil Procedure. After reviewing Meister's Verified Complaint, the Affidavit of Emily Meister, records and filings of the Court, and arguments of counsel, the Court makes the following FINDINGS OF FACT:

1. Defendant Tigress Sydney Acute McDaniel f/k/a Tosha Renae McDougal ("McDaniel") was given proper notice of Meister's request for a preliminary pre-filing injunction or gatekeeper order and of the scheduled hearing on such request.
2. Since 2012, McDaniel has caused to be initiated in Guilford County eleven (11) civil actions in the Small Claims Division, one (1) civil action in the District Court and four (4) actions in the Superior Court. McDaniel has also caused to be filed three (3) "Claim of Lien on Real Property" and two (2) "Notice of Lis Pendens".

3. McDaniel has caused three (3) matters to be appealed from the Small Claims Division to the District Court, has appealed one (1) District Court Arbitration Award and has filed two (2) Notices of Appeal which would require appeal to the North Carolina Court of Appeals. McDaniel has also caused to be filed in several of the civil actions requests for reconsideration, all of which have been denied or unsuccessful.
4. Many of the civil matters initiated by McDaniel involved claims against the same parties, or some of them, which claims arose from the same or almost the same underlying events. Additionally, several of the actions were re-filed despite previous dismissals with prejudice and/or while other actions filed by McDaniel against the same defendant(s) were still ongoing.
5. McDaniel has also caused to be initiated eight (8) criminal complaints; one (1) remains pending and, of the seven (7) that have been resolved, not a single conviction was had or obtained.
6. McDaniel has sought three (3) No-Contact orders pursuant to N.C. Gen. Stat. § 50C. All such requests were ultimately denied, and McDaniel has given notice of appeal with regard to the denial of her request against Meister.
7. Many of the claims filed or initiated by McDaniel have been dismissed at various stages due to the failure of McDaniel to appear and prosecute her claims.
8. The actions of McDaniel as described above have shown that she has filed baseless claims and motions for the improper purpose of harassing adverse parties, costing them unnecessary time and expense in responding to her filings.

9. McDaniel has placed an undue burden on the Fifth and Sixth Superior Court Judicial Divisions, causing expense and lost time to numerous Magistrates, District Court Judges and Superior Court Judges, as well as to that of the employees of the Clerk of Superior Court, the Trial Court Administrator, Judicial Assistants, and court reporters.
10. The history of McDaniel, who has acted *in forma pauperis* and *pro se* in the Matters involving Meister and the cases judicially noticed by this Court, demonstrates that she is either unable or unwilling to follow the requirements of North Carolina law, including the North Carolina Rules of Civil Procedure.
11. The repeated abuse of legal process by McDaniel requires that special limitations be placed upon her access to the courts. This Court has the inherent power to impose such special limitations as are reasonably necessary for the proper administration of justice and to provide solutions which enable the process of litigation to proceed smoothly. Aspects of that power include the authority to regulate and discipline those persons who appear before the Court to prevent impropriety and to fashion a remedy to meet the circumstances of each case.
12. The nature of McDaniel's conduct and the extraordinary circumstances of this matter, and other cases litigated by McDaniel *pro se*, require that the Court enter a gatekeeping order placing special limitations on McDaniel's access to the courts.

Based on the above FINDINGS OF FACT, the Court makes the following CONCLUSIONS OF LAW:

1. McDaniel has a history of filing vexatious, harassing and duplicative lawsuits which have caused adverse parties to incur needless expense, and have placed an undue burden on the judicial system.
2. This Court has considered lesser and alternative sanctions, but is of the opinion that such sanctions or alternatives would not adequately address the conduct of McDaniel or prevent the continued harm noted above.
3. The repeated abuse of legal process by McDaniel requires that special limitations be placed upon her access to the courts.
4. The following relief is necessary to protect Meister and other individuals and entities from further harassment and further to prevent needless waste of the court system's resources.

Based upon the foregoing FINDINGS OF FACT and CONCLUSIONS OF LAW, IT IS
HEREBY ORDERED that:

1. McDaniel shall be limited from initiating, filing or submitting in the Small Claims Division of the District Court of any county located within the Fifth and Sixth Superior Court Judicial Divisions any further complaint, motion, pleading or other document, unless such filing or document(s):

- (a) contains a certification by an attorney licensed under the laws of the State of North Carolina to practice law in North Carolina that, in the opinion of that attorney, the document complies with Rule 11 of the Rules of Civil Procedure; and

- (b) is first allowed by the Chief Magistrate Judge of the county in which such Small Claims Division is located and in which McDaniel seeks to file the document or initiate a proceeding.

2. McDaniel shall be limited from initiating, filing or submitting in the District Court of any county located within the Fifth and Sixth Superior Court Judicial Divisions any further complaint, motion, pleading or other document, unless such filing or document(s):

- (a) contains a certification by an attorney licensed under the laws of the State of North Carolina to practice law in North Carolina that, in the opinion of that attorney, the document complies with Rule 11 of the Rules of Civil Procedure; and
- (b) is first allowed by the Chief District Court Judge of the District Court Judicial District in which McDaniel seeks to file the document or initiate a proceeding.

3. McDaniel shall be limited from initiating, filing or submitting in the Superior Court of any county located within the Fifth and Sixth Superior Court Judicial Divisions any further complaint, motion, pleading or other document, unless such filing or document(s):

- (a) contains a certification by an attorney licensed under the laws of the State of North Carolina to practice law in North Carolina that, in the opinion of that attorney, the document complies with Rule 11 of the Rules of Civil Procedure; and

(b) is first allowed by the Senior Resident Superior Court Judge of the Superior Court Judicial District in which McDaniel seeks to file the document or initiate a proceeding.

4. McDaniel shall be limited from initiating or causing to be initiated any criminal charge(s) in any prosecutorial district located within the Fifth and Sixth Superior Court Judicial Divisions unless such charge(s) is first reviewed and allowed by the District Attorney for such prosecutorial district.


5. The restrictions contained herein shall be as to all filings in the Fifth and Sixth Superior Court Judicial Divisions, not just initial filings.

6. The Guilford County Clerk of Court shall cause a copy of this order to be sent to the attention of those Clerks of Court, Chief Magistrates, Chief District Court Judges and Senior Resident Superior Court Judges located within the Fifth and Sixth Superior Court Judicial Divisions.

7. Violation of this Order by McDaniel, or anyone on her behalf, shall be punishable by criminal and/or civil contempt.

8. This Preliminary Gatekeeper Order shall remain in effect until such time as a final determination of Meister's request for a permanent Gatekeeper Order has been made.

When reviewing the Odyssey record **13R000367-890 (attached)**, I discovered that your office indexed the record and designated me as petitioner for the registration of the gatekeeper, which is completely false.

Emily Jeffords Meister, by and through Keith Black, and Carl Fox and/or Webb were the petitioner(s) for the registration of the gatekeeper order in your county. The registration itself shows that.
